These Thena Product Terms supplement the hackajob <u>Terms and Conditions</u> ("Main Terms") and apply where the Client subscribes to or uses the *Thena* product. Capitalised terms have the same meaning as in the Main Terms.

1. Description of Services

- 1.1 Thena is an Al-powered CV-screening and ranking platform within the hackajob Product Suite. 5.2 hackajob makes no warranty that the Thena outputs will be free from error or bias and does not assume responsibility for the Client's hiring decisions.

6. Service Availability and Support

6.1 hackajob shall use commercially reasonable endeavours to ensure the availability of Thena twenty-four (24) hours a day, seven (7) days a week, excluding planned maintenance.

6.2 Support for Thena is available during standard business hours (9:00 a.m. – 5:00 p.m. GMT) via support@hackajob.com, in accordance with the general SLA contained in the Main Terms.

7. Termination and Data Return

7.1 Upon termination of the Client's Thena subscription, hackajob shall, at the Client's written instruction, delete or return all applicant data processed within Thena within thirty (30) days, except to the extent retention is required by Applicable Law.

7.2 Termination of these Thena Product Terms shall not affect the validity or continuation of the Main Terms for any other hackajob products.

8. Incorporation

These Thena Product Terms form part of and are incorporated into the Main Terms. In the event of a conflict, these Thena Product Terms shall take precedence for matters relating specifically to Thena.
